

2027 SHERWIN-WILLIAMS® OFFICIAL CALENDAR CONTEST RULES

1. **Eligibility:** The Contest is open only to legal residents of the fifty (50) United States (including DC) and Canada who are at least eighteen (18) years old. Employees of The Sherwin-Williams Company, as well as the immediate family (spouse, parents, siblings and children) and household members of those employees are not eligible to enter.

2. **How to Enter**

- a. **Automotive Professional Photography:** Take pictures of a vehicle that was refinished exclusively using Sherwin-Williams®, Valspar® or House of Kolor® coatings topcoat products (your “Entry”). **Your Entry must include at least two (2) high-resolution (300 DPI or higher) pictures from different angles.** Pictures should focus on the vehicle only and should not prominently feature people, third-party products or unrelated objects.

Aerospace Professional Photography: Take pictures of an aircraft (business jet, regional jet, commercial airline, single/twin engine, kit plane, sport plane, helicopter, etc.) that was refinished exclusively using Sherwin-Williams® Aerospace Coatings topcoat products (your “Entry”). **Your Entry must include at least two (2) high-resolution (300 DPI or higher) pictures from different angles.** Pictures should focus on the aircraft only and should not prominently feature people, third-party products or unrelated objects.

- b. **Entry Requirements:** Your Entry must: (i) include a complete list of all products used along with all requested information regarding the vehicle or aircraft and the facility that completed the refinishing work; (ii) not violate any third-party rights, including but not limited to copyrights or trademark rights; (iii) not prominently feature any third-party trademarks, logos or content you do not own or have permission to use; and (iv) include optional short-form video content, if available, showcasing the build, finish process or story behind the project. Selected videos may be featured across Sherwin-Williams and associated brand marketing channels.
- c. **Submit Your Entry:** Submit your completed Entry, along with media images through the applicable contest links by 11:59 PM EST on August 14, 2026.

store, copy, transmit, publish, post, broadcast, display, publicly perform, exhibit and otherwise use your Entry (including, but not limited to, pictures, videos, the name of the painter and shop, likeness or any statements attributed to the work) in any media throughout the world, without additional review, compensation or approval from you or any other party; (b) forever waive any rights of copyright, trademark, privacy and any other legal or moral rights that may preclude Sponsor's use of your Entry; and (c) agree not to file, make, support or authorize any action, claim or lawsuit against Sponsor on the grounds that any use of your Entry infringes any of your rights as creator of your Entry, including without limitation copyrights, trademark rights and moral rights.

4. **Judging:** Sponsor will select twelve (12) potential winners for each calendar based on the following Judging Criteria: finish quality, technical difficulty, design originality and artistic merit. The odds of winning depend on the relative performance of each entrant.
5. **Potential Winner Requirements:** In order to win a prize, a potential winner may be required to complete and return the following documents: (a) a declaration of eligibility and release; and (b) a license confirming the rights described in Section 3. If a potential winner fails to sign and return any required documents within five (5) days of notification, he/she will forfeit the prize and Sponsor may select an alternate potential winner according to the Judging Criteria. **Sponsor reserves the right to verify each winner and the use of Sherwin-Williams®, Valspar®, House of Kolor® or Sherwin-Williams Aerospace Coatings products.**
6. **Prizes:** Each winner will have his/her Entry featured in the 2027 calendar. In addition, each winner will receive twenty (20) complimentary copies of the calendar and may be recognized by Sherwin-Williams®, Valspar®, House of Kolor® or Sherwin-Williams Aerospace Coatings through press releases, social media spotlights, websites and other marketing channels. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt. The Contest is subject to all applicable laws and regulations and is void where prohibited.
8. **Release and Limitation of Liability:** By entering, you agree to release and hold Sponsor, its parents, subsidiaries, affiliates and each of their respective officers, directors, employees and agents (the "Released Parties") harmless from and against any and all liability, claims, actions, loss, harm, damage, injury, cost or expense, including attorney's fees (collectively, "Claims") arising out of your participation in the Contest. You further agree to indemnify, release and hold the Released Parties harmless from any Claims that their use of your Entry, as contemplated herein, violates or infringes upon the rights of any third party.

9. **Disputes:** Except where prohibited, you agree that any disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Ohio. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Contest, shall be governed by and construed in accordance with the laws of Ohio, without giving effect to any choice of law or conflict of law rules.
